## **Portfolio Information**

A summary of the number of project submissions the program has received between January 2023 and March 2023, and what project stage and Technology Area each submission represents can be found in Table 1 below. Overall, this quarter saw an increase of project submissions from last quarter (48 in Q1 compared to 27 in Q4). The "Deferred" project classification means these projects will not move forward at this time but will be revisited once a quarter to reassess if they meet future program needs and priorities.




Figure 1: Program Participant Type




Figure 2: Selected Project Expected Completion Year (Target # Reflected as Line)
