Portfolio Information


Overall, during Q1, the team saw a decrease in project submissions from Q4 2023 (**30** submissions in Q1 versus **51** submissions in Q4) The "deferred" project classification means these projects will not move forward at this time but will be revisited intermittently to reassess if they meet future program needs and priorities.




Figure 1: Program participant type

Figure 1 gives a breakdown of where this quarter's project and idea submissions came from, classified by submitter type.



Figure 2 displays a pipeline of projects that CalNEXT expects to be completed in each year of the program based on projects that have been selected for the program portfolio. This figure includes any projects that have been completed. As the figure shows, the program has 42 expected projects in 2024, 2 more than the required amount in order to meet 2024's program goals.
